DI works to build peace and resilience, the foundations of accountable politics and governance. ### **SPOTLIGHT: ELECTION AND DEMOCRACY ACTIVITY IN LIBERIA**



In partnership with USAID/Liberia, we are currently implementing the Election and Democracy Activity (EDA). EDA aims to enhance civic knowledge and sense of duty among citizens, provide technical support to the National Elections Commission and election observation groups, and increase leadership of marginalized groups in political processes—with a particular emphasis on women and youth. Collaboration though this five-year project will include national and international partners as well as local civil society organizations and groups serving local communities.









### Bangladesh

We are building relationships between parties and constituents, supporting justice sector reform, and preventing political violence and violent extremism.

### **Ethiopia**

We are supporting the most viable new political parties to participate in meaningful dialogue and engage in legitimate political processes.

### **El Salvador**

We are providing analytical support to USAID's local governance project, which aims to strengthen decentralization and increase security.

### Jamaica

We are strengthening communities using evidenced-based violence prevention resources and supporting local initiatives with cuttingedge social and behavioral science approaches.

### South Sudan

We are promoting an inclusive peace process, accountability, and national cohesion by protecting and strengthening civil society.
