Youth Excel is pleased to announce a Request for Applications for a Local Implementing Partner to colead the Youth Excel Activity in Cambodia with the IREX Youth Excel Global team. This activity will help develop a more nuanced understanding of Cambodian youth priorities and interests and provide pathways for USAID/Cambodia of how and in what areas to effectively engage diverse youth in Mission programming.

The Local Implementing Partner will help facilitate a youth-led gender, inclusion, and protection assessment; co-plan and facilitate a Data and Innovation Summit; participate in the selection and mentorship of youth innovators; and co-write knowledge products. The Local Implementing Partner will manage approximately \$65,000-\$75,000 for a 10-month period. Please see full information in the following Request for Applications.

Overview

About Youth Excel: The <u>USAID-funded Youth Excel</u>: Our <u>Knowledge Leading Change program</u> implemented by IREX and its consortium supports young leaders and youth-led/youth-serving organizations (YL/YSOs) around the globe to conduct quality "research-to-change" (implementation research); use data and learnings to improve their own cross-sectoral, positive youth development programs; synthesize data and learning; and engage in intergenerational dialogue with adult decision-makers so together youth and adults can shape and advance data-informed development policies, agendas, and programs.

About the Youth Excel Activity in Cambodia: The Youth Excel Cambodia activity will develop a more nuanced understanding of Cambodian youth priorities and interests and provide pathways for the Mission of how and in what areas to effectively engage diverse youth in Mission programming. Youth Excel will support youth priorities that align with USAID strategy and build on existing activities and the existing body of knowledge. In the longer term, Youth Excel's activity will support the Mission to better integrate youth priorities and youth voice in the programming cycle.

Breakdown of Stakeholder Roles:

- IREX, Youth Excel prime award holder: provide technical leadership for the Youth Excel / Cambodia buy-in activity.
- Local Implementing Partner: co-lead the activity, with support from IREX.
- Youth-led organizations: receive small grants managed by IREX and the Local Implementing
 Partner to implement youth-led innovation solutions with implementation research approaches
 to strengthen effectiveness in their work.

























About the Local Implementing Partner: To support this activity, Youth Excel seeks a qualified organization to be the Local Implementing Partner to co-lead the Youth Excel activity alongside IREX. The partner will conduct learning activities, engaging youth researchers and youth-led/youth-serving organizations and mobilizing knowledge to help integrate youth priorities and voices in future development programming. Through its Youth Excel work, the local partner will strengthen its capacity in Positive Youth Development (PYD)-focused implementation research and gender equality and social inclusion (GESI), and protection, as well as in subaward management and compliance.

Learning Goals (What are we learning in this activity?)

- Deepen understanding of diverse Cambodian youth's priorities for national investments (such as USAID programming and other national/regional programming) in the following areas:
 - Gender and social inclusion (GESI)
 - Youth Protection
 - Thematic interest areas
 - Regional focus areas
- Test approaches to inclusive intergenerational engagement and generate recommendations to achieve it.
- Explore any changes (external or internal to the organizations) that may occur from embedding implementation research within youth-led organizations, and surface lessons learned from youth-led implementation research.

Issuance of this request for applications does not constitute an award commitment on the part of Youth Excel, nor does it commit Youth Excel, IREX, or USAID to pay for costs incurred in the preparation and submission of an application. The application is submitted at the risk of the applicant. All preparation and submission costs are at the applicant's expense.

What is the Local Implementing Partner's Scope of Work?

- I. Participate in a two-week intensive on-boarding with IREX following subaward approval. This includes selecting its capacity development priorities; on-boarding to Youth Excel approaches and tools, and finalizing target communities for this activity.
- 2. Participate in Mission consultations to determine geographic priorities for Youth Excel/Cambodia, identify key national-level stakeholders, give input to the outline for a youth organization mapping exercise, and support the local IR advisor. Hold initial consultations with selected national stakeholders in coordination with IREX.
- 3. Lead the outreach, selection, and management of the youth advisory group in coordination with the USAID mission.
- 4. Adapt and facilitate the Intersectional Rapid Gender and Protection Analysis (IRGPA). This includes recruiting and facilitating five to six diverse young researchers in each target district (10-16 total, for two to three districts) to conduct the IRGPA, and adapting the Youth Excel IRGPA tool for the Cambodian context. Coordinate closely with the IREX team in this activity.
- 5. Collaborate with IREX to prepare the agenda and manage preparations and logistics for an interactive intergenerational dialogue event (Data and Innovation Summit), in November 2022. The event will pilot-test approaches to effectively engage youth and decision-makers.
- 6. Support youth innovation and learning in selected thematic area through small grants. Three to five youth-led organizations will receive up to \$10,000-\$20,000 each for approximately four

























- months to conduct an implementation research activity around the selected theme and youth digital leadership.
- 7. Support the creation of the final Learning Brief and disseminate it through social media, the local partner's network, external stakeholders, and Mission contacts, and through holding a Virtual Showcase in April 2023.
- 8. Support program monitoring, evaluation, learning, and reporting of activities, as guided by the Youth Excel Global Monitoring, Evaluation, and Learning (MEL) advisor.

Target geography: Activities will engage youth from two to three provinces with a mix of urban and rural geographies. This activity will engage youth from hard-to-reach geographies, including indigenous populations. Final geographic selection will be determined with the Mission and the Local Implementing Partner.

Target Participants: Target participants include diverse young leaders ages 15-30 and youth-led/youth-serving organizations (YL/YSOs) that offer Positive Youth Development (PYD) programming in priority USAID sectors. Target participants will also include the young people that are served by programs and initiatives led by young leaders and YL/YSOs, communities that they serve, and the Mission team.

What are Youth Excel's key technical approaches?

The Local Implementing Partner will help apply the following key technical approaches to the Youth Excel Cambodia Activity:

- Gender equality and social inclusion (GESI) is an approach that helps us to understand the
 importance of equal rights and opportunities for all individuals regardless of their social identity.
 This concept addresses unequal power relations between different social groups that cause
 exclusion.
- **Protection** is an approach that helps us to understand and prepare for protection concerns related to Youth Excel, which can be digital, physical, and psychosocial. Youth Excel partners take local protection measures to prevent, mitigate, and respond to risks and threats that Youth Excel can unintentionally exacerbate (risks associated with programs, operations, and people). Youth Excel aims to understand the specific risks, but also the protection capacities, the available resources, and the right to protection of participants.
- Research-to-Change (implementation research): Information is a powerful resource that can be used to help organizations grow and make their programs work better. "Research-to-Change" (implementation research) is a tool that allows organizations to gather data, take what they learn, and turn it into what they do in real-time.
- Knowledge mobilization is Youth Excel's 'rebrand' of knowledge management and
 dissemination. It includes creating knowledge products that are easily accessible by users, making
 them openly available to the public for use, and sharing them in a strategic and dynamic way that
 promotes dialogue and two-way communication (including events and social media, for
 example).

























Knowledge Products share learning and enable the audience to act based on that learning from the Research-to-Change process. Knowledge products can have different formats, such as manuals, best practices briefs, or data-based recommendations. Knowledge products can be created using different methodologies, like summaries, storytelling, and digital visualizations and take different forms, such as printed documents, podcasts, radio, videos, etc.

Capacity development supports youth-led and youth-serving organizations to strengthen
skills and leverage opportunities in the following areas: using implementation research to
strengthen positive youth development programs; applying gender, inclusion, and protection so
that programs are more inclusive of diverse youth groups; strengthening opportunities for
meaningful youth engagement and intergenerational dialogue; synthesizing, disseminating, and
using findings from research more effectively; and managing subawards, including planning,
budgeting, reporting, and compliance.

Who can apply to the Request for Applications?

The Request for Applications for the Local Implementing Partner is open to **local, registered, youth-led or youth-serving organizations** that meet the following minimum criteria and share Youth Excel objectives. Organizations led by and serving youth from marginalized groups, which may include age, gender, disability, ethnicity, and other identities, are encouraged to apply.

What kind of grant is available for the role?

- Purpose: co-facilitate the Youth Excel activity in Cambodia
- Location: Cambodia
- **Number:** One. Youth Excel reserves the right to fund any or none of the applications submitted.
- Type: Fixed amount award or cost reimbursement grant. Fixed amount award payments would be made based on successful completion of milestones. Cost reimbursement grant payments would be made based on monthly program and financial reporting in line with successful completion of project milestones. <u>ADS Reference 303mat</u> Mandatory Standard Provisions for Fixed Amount Awards to Non-Governmental Organizations apply.
- Amount: Approximately USD \$65,000-\$75,000. Applicants can propose the amount required
 for project implementation within this range. For those applicants with the capacity and interest
 in also administering the Youth Innovators Small Grants Activity, please budget an additional
 \$64,000 as a line item fully allocated toward subgrants.
- **Start:** August 2022.
- Length: 10 months.'

























What types of costs can you request for funding as part of this activity?

You can cost your activities using the following recommendations for the 10-month project timeframe and \$65,000-\$75,000 funding range. IREX will assess and negotiate cost allowability, realism, and effectiveness in alignment with the workplan.

<u>Leadership and coordination of Local Implementing Partner activities:</u> Your organization is encouraged to identify a team of local staff to coordinate the Local Implementing Partner role, including administration, logistics, data, and communications support for your specific needs.

Cost Recommendations: Compensation for the time of staff leading and coordinating the Local Implementing Partner activities and other coordination support may be salaries/benefits, consulting fees, internship or other stipends. Costs to cover internet connectivity for meetings and other collaboration with a global team and communications with teams in more remote provinces.

Inclusion and protection strategies for diverse youth participation

Cost Recommendations:

- Compensation for protection focal point, who could be your project or research lead/manager or another team member, for approximately I day per week dedicated to protection.
- 3% of the total budget for inclusion and 5% for protection related costs.

<u>Capacity strengthening resources:</u> Your organization is encouraged to identify capacity strengthening resources to support for your specific needs to fulfill the Local Implementing Partner role.

Cost Recommendations: You may budget for 5% capacity strengthening resources. IREX will review with you what type of financial support and/or direct technical support and other resources that Youth Excel can provide.

Cost Restrictions: the RFA cannot fund the following types of costs:

- Subawards to other organizations, unless approved to administer the Youth Innovators Small Grants activity
- Solution of Costs, such as executive and administrative salaries, rent and utilities, and bank fees. However, you may request 10% of the budget as Youth Excel's contribution to your organizational costs. All organizations are eligible for the standard 10% de minimis indirect cost rate of modified total direct costs per 2 CFR 200.414(f), or may provide a negotiated indirect cost rate agreement with the U.S. Government.
- × Profits and fees
- ✗ Limitations on equipment/supplies
 - o Items with a unit cost of \$5,000 or more and a useful lifespan of I year or more are defined as "equipment" and will not be funded by this grant competition.

How will applicants be evaluated and selected for the Local Implementing Partner role?

Selection Criteria: applications will be holistically reviewed and scored on the following 4 factors:

- Strong ability to work with diverse youth at the national level with different stakeholders to achieve programmatic goals in the youth sector.
- Technical capacity in: youth engagement, stakeholder engagement, learning approaches, and capacity development.
- Feasibility of budget and organizational capacity to manage donor funded projects of similar size and scope
- Technical capacity to utilize inclusion and protection strategies for diverse youth.

Selection Process: Applications will be reviewed by Youth Excel members, including youth from around the world, with diverse perspectives and a range of regional, technical, and grant expertise. Youth Excel will take measures to respect confidentiality of applicants' intellectual property and prevent conflict of interest¹ and other biases² in the selection process.

- Eligibility screening: An IREX grants team will conduct an initial review of the
 applications, based on the following eligibility requirements, and disqualify applications that
 are not eligible for consideration.
 - Does application satisfy the basic parameters of the RFA?
 - Does application fulfill the eligibility criteria?
 - Is application complete and submitted on time?
- 2. **Shortlisting:** An IREX technical team will conduct merit review of all eligible applications, based on the selection criteria.
- 3. **Finalist Selection:** The Youth Excel review panel, comprised of IREX and partner staff, Global Youth Advisory Council members and other youth representatives, and USAID staff will use the selection criteria to select finalist(s) from each of five global regions.

Notifications to all applicants will be made to the point of contact who submitted the application. The selection of an application in accordance with these established criteria and processes does not guarantee an award. Awards are contingent on successful workplan-budget negotiations, risk assessment, and IREX and USAID approval.
